## AGREEMENT:

In consideration of being allowed to participate in activities conducted at the Town of Berwick Civic Center, on Saturday, January 30, 2020, I \_\_\_\_\_ (SSN XXX-XX-\_\_\_\_\_) (participant of guardian if under 18) acknowledge, appreciate, and agree:

1. The risk of injury from activities involved in the program which I will participate in at the Berwick Civic Center exists, including the potential for permanent paralysis, death, and serious personal injury. I agree that while particular rules, equipment, and personal discipline may reduce the risk, the risk of injury does exist.
2. I knowingly and freely assume all risks for personal injury, both known and unknown, in any way connected with the use of the facilities at Berwick Civic Center. I assume full responsibility for my actions.
3. I agree to comply with the state and customary terms and conditions for participation.
4. If I observe and hazard, defect or unsafe situation or conditions during my presence at the Berwick Civic Center, I will remove myself from participation in any activities at the Berwick Civic Center and bring immediately such situation or condition to the attention of the nearest Town of Berwick official.
5. I understand it is my duty and I obligate myself to inspect the entire premises. Both inside and outside, at the Berwick Civic Center. I obligate myself to immediately report and provide notice to the Chief Administrative Office of the Town of Berwick (985-384-8858) of any defect, unsafe or dangerous condition at the Berwick Civic Center. I further agree that I will not participate in any program at the Berwick Civic Center after I have observed any defect, unsafe or dangerous condition of the premises or facilities at the Berwick Civic Center.

I, for myself on behalf of my heirs, successors and assigns, release and agree to hold harmless the Town of Berwick, their officers, officials, agents, and/or employees, from any claims due to injury, disability, death, or loss or damage to my person or property, in any way connected with or arising out of the use of the premises at the Berwick Civic Center.
7. The above stated agreements are separable and independent of each other. If any agreement or provision is found to be unenforceable all remaining terms and agreements shall remain enforceable.
