I further agree that I will not participate in any program at the Berwick Civic Center after I have observed any defect, unsafe or dangerous condition of the premises or facilities at the Berwick Civic Center.
- I, for myself on behalf of my heirs, successors and assigns, release and agree to hold harmless the Town of Berwick, their officers, officials, agents, and/or employees, from any claims due to injury, disability, death, or loss or damage to my person or property, in any way connected with or arising out of the use of the premises at the Berwick Civic Center.
